## Course Overview

The Attention, Impulsivity, Regulation (AIR) team from the UC Davis MIND Institute will present state-of-the-art information on the diagnosis and treatment of ADHD, including how we can use neuroscience findings to guide our understanding of ADHD, related disorders and the development of new treatments for ADHD. The information will be geared toward clinicians, researchers, and family members.

## Course Objectives

1. Increase knowledge of evidence-based approaches to diagnosis in ADHD.
2. Gain appreciation for developmental progression of ADHD.
3. Learn about different subtypes (i.e., "presentation types") of ADHD and implications for treatment.
4. Develop understanding for the role of medication in ADHD, and types, assessing the use of medication and associated benefits and potential side effects.
5. Nonpharmacological approaches to ADHD, including current treatments and future directions.
6. Learn about co-morbid disorders associated with ADHD, including the link between substance use disorders and ADHD and self-harm.
7. Enhance understanding of how neuroscience findings relate to everyday functioning for persons with ADHD.

## Presenters

### Julie B. Schweitzer, Ph.D.

Dr. Schweitzer is Professor, Department of Psychiatry and Behavioral Sciences, Director of the Attention, Impulsivity and Regulation (AIR)/ADHD Program at the MIND Institute at the UC Davis School of Medicine and Director, UC Davis Schools of Health Mentoring Academy. Her goal is to apply translational research methods using a combination of behavioral and physiological methods (e.g., fMRI) to better characterize and develop targeted treatments for self-control and attentional disorders in children and adults. This includes identifying subtypes of attentional and impulse-related disorders associated with attention deficit/hyperactivity (ADHD). In addition, she conducts investigator-initiated clinical trial research using cognitive and psychopharmacological approaches in ADHD and autism. She has a long history of studying reward-related functioning across populations, including, typical development, ADHD, schizophrenia and substance use disorders. She is also currently funded for communication and dissemination projects for ADHD.

### Catherine Fassbender, Ph.D.

Dr. Fassbender is an Assistant Professional Researcher within the UC Davis Department of Psychiatry and Behavioral Sciences. She is a cognitive neuroscientist whose interests include understanding the neural correlates of cognitive control processes in the typically developing brain, in ADHD and in substance abuse, through the use of behavioral, functional neuroimaging and electrophysiological methods. Dr. Fassbender's goal is to better understand the cognitive impairments in ADHD in order to inform targeted treatments and to identify patterns of brain and behavior function that will inform the early identification of individuals vulnerable to substance dependence with the goal of prevention.

### Murat Pakyurek, M.D.

Dr. Pakyurek is a Clinical Professor and the Director of Child and Adolescent Psychiatry Division at UC Davis Medical Center. He is also the medical director for UC Davis Department of Psychiatry Outpatient Clinics and the medical director at The MIND Institute ADHD Clinic. Dr. Pakyurek's clinical interests are care delivery systems, childhood mood disorders, ADHD, and Autism Spectrum Disorders. He is involved in education and training of medical students and general psychiatry as well as child and adolescent psychiatry residents.
