

Course Overview

The objective of this year's symposium is to explore the opiate epidemic. Presentations regarding the current range, impact, and preventive strategies based on scientific, treatment, community and personal/family experiences will be reviewed and discussed at this comprehensive symposium with both national and local considerations.

To ensure that we examine this multifactorial topic from all perspectives, the morning speakers will be joined in the afternoon by local experts for a panel discussion with questions from the audience. This program will be of interest to medical and behavioral health professionals as well as educators, law enforcement personnel, parents and students.

Course Objectives

1. Describe the legal changes that occurred in 2016 that impacted opioid use.
2. Differentiate between addiction to opiates and opioids related to chronic pain and recreational use by youth.
3. Articulate beneficial aspects of medication assisted treatment.
4. List three signs and symptoms of addiction/opioid/opiate use.
5. Identify and describe two behavioral treatment strategies for opiate use.

In 1995, the Calciano family lost Jon, their 23-year-old son, and brother, to suicide. After two years of collaboration with the Dominican Hospital Foundation, the family inaugurated the Jon E. Nadherny/Calciano Memorial Youth Symposium to strengthen adolescent behavioral health resources in our community. These annual symposia enable local families, educators, and mental and medical health professionals to hear and interact with renowned specialists in a wide range of timely topics. Over the past twenty years, areas of focus have ranged from suicide to bullying, ADHD, substance abuse, and gender identity.

Presenters

Dr. David Thomas

After 12 years as a pain and opioid researcher, in 1995 Dr. Thomas joined the National Institute on Drug Abuse (NIDA) where he has managed much of NIDA's pain and opioid research efforts. In 2015, he joined DESPR's Services Research Branch. He currently is co-chair of the NIDA Prescription Opioids and Pain workgroup, which fosters pain and opioid research and education. He is also a founding member of the National Institutes of Health (NIH) Pain Consortium, which promotes pain research across the NIH. He is also a member of the Department of Health and Human Services Behavioral Health Coordination Committee Prescription Opioids Subcommittee, National Pain Strategy working group on Provider Education, and the Interagency Pain Research Coordination Committee. Dr. Thomas served as the NIH liaison to the CDC in the development of the CDC guidelines on opioid prescribing for chronic pain. Dr. Thomas is also the lead on the NIH Pain Consortium Centers of Excellence in Pain Education which is promoting pain education in medical, dental, nursing, pharmacy and other professional schools.

Dr. Sarah Duffy

Dr. Duffy joined NIDA's Services Research Branch (SRB) in 2006, where she is responsible for the economics, opioid use disorder treatment services research, and quality measurement and management of extramural research grant portfolios. Prior to joining NIDA, she spent eight years as a senior research economist at the Office of Applied Studies at the Substance Abuse and Mental Health Services Administration (SAMHSA) where she used data from large national data collection projects, including the National Survey on Drug Use and Health (NSDUH) and the Treatment Episode Data Set (TEDS), to conduct economic and health services research on substance abuse treatment and costs. Prior to joining SAMHSA, Dr. Duffy worked for the Maryland Health Services Cost Review Commission and the U.S. Agency for Healthcare Research and Quality where she published several articles in the substance abuse treatment, health services research, and economics literatures. She received her Ph.D. in economics from the University of North Carolina, Chapel Hill.

Shaina Zurlin LCSW

Shaina Zurlin is a Licensed Clinical Social Worker and doctoral candidate with more than 15 years of experience in behavioral health service provision and administration. Her clinical expertise lies in motivational interviewing, gender responsive trauma informed care, and cultural transformations in a range of milieus. Emphasizing a holistic strengths-based approach, Ms. Zurlin connects with clients, participants and multidisciplinary staff to generate successful and sustainable change which best meets individualized needs in dynamic, supportive settings. She has delivered vibrant and engaging presentations to a variety of audiences in such venues as the California Department of Health Care Services Substance Use Disorders Statewide Conference, the California Quality Improvement Coordinators Conference, the California Department of Public Health, the University of California San Francisco, San Diego State University and Zuckerberg San Francisco General Hospital.
